

INSTRUCTIONS FOR AUTHORS

Manuscripts submitted scientific papers, after the editorial assessment, included in the review process of competent experts. Reviewers did not know the identity of the author or authors receive information about reviewers. On the basis of reviews, editorial staff makes decision on publishing, correction or rejection of the paper. Shareholding Journal publishes only previously unpublished scientific and professional papers in the field of management. If the article is an earlier amended or modified work, authors are required to submit a copy of the first operation.

Shareholding Journal is published annually, manuscripts should be submitted via e-mail throughout the year to address editorial cefibeograd@gmail.com. Basic information about the letter and scope of work Letter handwriting is on Serbian language. Papers may be published in English or another foreign language. Length font handwriting articles is up to 30 000 characters (with whitespace), not counting the footnotes-note. The font is Cambria 12. Footnotes are entered Cambria font size 10 and not used for citation. The page size is 5 with 2 cm margins on all sides. Line spacing of the text is 1.2.

The structure of the article information about the author or authors are placed at the beginning of the work, according to the font used for the main text, Cambria 12. Include the name and surname.

After last names in footnotes-note states affiliations of authors and includes an institution where the author is employed as the electronic address of the author. If the work was created in the context of a specific project, it is in a footnote, the information on the number of projects, its managers and institutions financing the project.

The title should as accurately indicates the content of the article and to facilitate indexing and search topics. The title is written centered, in capital letters, bold.

Abstract (summary) must include introductory sections on research, earlier observations about the problem, applied methods, clear and concise results and thinking about the impacts and implications of the discovery. The abstract are only the most important details that are necessary to understand the nature of the article. The volume of abstracts of 150 to 200 words, written in the language of work, Serbian and English.

The editorial board provides translations of abstracts of foreign authors in the Serbian language. Keywords should not contain words from the title, but essential words which are drawn from the content of the work. You need to write up to 10 keywords. One is at the beginning of the allegations with the abstract.

At the end of the article comes Literature (in describing the benefits of the APA (American Psychological Association) style. At the end of the text in the lower right corner, editorial chronological order stating the dates of receipt, approval and possible corrections work. Work may include subheadings. They centered and not written in capital letters, but bold.
